No. SUP.70/2006/581 – In continuation of this Department's Advertisement No.SUP.70/2006/576 dated 21st June, 2021 for filling up of the posts of Members of the District Commissions, Food Civil Supplies & Consumer Affairs Department hereby extends the last date of applying for the posts of Members in the State Commission by another 15(fifteen) days of issuance of this advertisement i.e. upto 16th August, 2021, in the following Districts:-

- (i) Ri-Bhoi District, Nongpoh
- (ii) East Jaintia Hills, Khliehriat
- (iii) South West Garo Hills, Ampati
- (iv) South Garo Hills, Baghmara

Interested and eligible candidates, are invited to submit their applications alongwith resume and relevant certificates to the Office of the respective Deputy Commissioner of the concerned district on or before the **16th August, 2021**.

The candidates who have already applied need not apply again as their candidature and applications are still valid subject to eligibility and age criteria.

1. As per Rule 4(2) of the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Rules,2020, the eligibility criteria is as follows:-
 - (i) The applicant should not be less than thirty-five years of age;
 - (ii) The applicant should possess a bachelor's degree from a recognised University; and
 - (iii)The candidate should be a person of ability, integrity and standing, and having special knowledge and professional experience of not less than fifteen years in Consumer Affairs, Law, Public Affairs, Administration, Economics, Commerce, Industry, Finance, Management, Engineering, Technology, Public Health or Medicine
2. Total number of Posts - 2 (for each District)
3. Number of Posts reserved for women - 1 (for each District)
4. The applicant upon selection for the post of Member of the District Commissions, shall have a tenure of four years or up to the age of sixty-five years whichever is earlier.


