**Filling up of the post of President of the District Consumer Disputes Redressal Commissions.**

Applications are invited from eligible candidates for appointment to the post of President in the District Consumer Disputes Redressal Commissions in the following Districts:-

1. East Jaintia Hills, Khliehriat
2. South West Garo Hills, Ampati
3. South West Khasi Hills, Mawkyrwat
4. North Garo Hills, Resubelpara
5. South Garo Hills, Baghmara.

**ELIGIBILITY CRITERIA**

In terms of Rule 4 of the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Rules, 2020 made by Central Government in exercise of the powers conferred by section 29, and 43, read with clauses (n) and (w) of sub-section (2) of section 101 of the Consumer Protection Act, 2019 (35 of 2019).

(1) A person shall not be qualified for appointment as President of District Consumer Disputes Redressal Commission, unless he is, or has been, or is qualified to be a District Judge;

**DISQUALIFICATIONS**

A person shall be disqualified for appointment as President of a District Commission if he –

- a) has been convicted and sentenced to imprisonment for an offence which involves moral turpitude ; or
- b) has been adjudged to be insolvent ; or
- c) is of unsound mind and stands so declared by a Competent Court ; or
- d) has been removed or dismissed from the service of the State Government or Central Government or a body corporate owned or controlled by such Government ; or
- e) has, in opinion of the State Government, such financial or other interest as is likely to prejudicially affect his functions as the President.

### **SELECTION COMMITTEE**

*(1) The President and members of the State Commission and the District Commission shall be appointed by the State Government on the recommendation of a Selection Committee, consisting of the following persons, namely :-*

- (a) Hon'ble Chief Justice of the High Court or any Judge of the High Court nominated by him-  
Chairperson ;*
- (b) Secretary in charge of Consumer Affairs of the State Government – Member ;*
- (c) Nominee of the Chief Secretary of the State – Member.*

### **REMOVAL**

*(1) The State Government shall remove from office any President, who -*

- (a) has been adjudged as an insolvent ; or*
- (b) has been convicted of an offence which involves moral turpitude ; or*
- (c) has become physically or mentally incapable of acting as such member ; or*
- (d) has acquired such financial or other interest as is likely to affect prejudicially his functions as  
a member ; or*
- (e) has so abused his position as to render his continuance in office prejudicial to public interest ;*

*Provided that where a President is proposed to be removed on any ground specified in clause (c) to (e) of the Consumer Protection (Qualification for appointment, method or recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission)Rules, 2020, the President shall be informed of the charges against him and given an opportunity of being heard in respect of those charges.*

### **TENURE**

*The President of the District Commission shall hold office for a term of four years or upto the age of sixty-five years, whichever is earlier and shall be eligible for reappointment for another term of four years subject to the age limit of sixty five years, and such reappointment is made on the basis of the recommendation of the Selection Committee.*

### **REMUNERATION AND OTHER TERMS AND CONDITIONS**

*The President of the District Commission shall be entitled to the salary and allowances as are admissible to a District Judge in the super time scale of pay if appointed on a whole time basis.*

*Fixation of pay of the persons retired from the post of District Judge, appointed to the posts of President on whole time basis, shall be on the basis of the pay last drawn reduced by the amount of pension.*

*(This is subject to any modifications, if made in future, in the pay structure by State Government).*


### **OATHS OF OFFICE AND SECRECY**

*Every person appointed to be the President shall, before entering upon his office, make and subscribe an oath of office in **Form – I** and oath of secrecy in **Form – II** annexed.*

*Applications of eligible candidates, willing to be considered for the post of President in the said District Commissions in the attached proforma may be sent to Secretary, Meghalaya State Consumer Disputes Redressal Commission (State Commission), New Administrative Building, Lower Lachumiere, Shillong – 793001 , so as to reach by 5<sup>th</sup> July, 2021. Applications which are incomplete or lacking in any details / documents as asked for or which are received after the due date 5<sup>th</sup> July, 2021 shall not be entertained.*

*The persons selected for appointment will have to join within 30 days from the date of issue of appointment order.*
