**No.SUP.24/2021/Pt./514-** As per Section 42 and Section 43 of the Consumer Protection Act,2019 and Rule 3(2), and Rule 6 of the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Amendment Rules, 2023 applications are invited from interested candidates for appointment to the posts of Member of the Meghalaya State Consumer Disputes Redressal Commission, henceforth, which shall be known as the '**State Commission**', Meghalaya. The eligibility criteria is as follows:-

1. The applicant should not be less than forty years of age;
2. The applicant should possess an experience of at least ten years as presiding officer of a district court or of any tribunal at equivalent level or combined service as such in the district court and tribunal; OR
3. The candidate should possess a bachelor's degree from a recognised University and is a person of ability, integrity and standing, and has special knowledge and **professional experience of not less than ten years** in Consumer Affairs, Law, Public Affairs, Administration, Economics, Commerce, Industry, Finance, Management, Engineering, Technology, Public Health or Medicine.
4. The Selection shall be on the basis of performance in a written test consisting of two papers as specified in the table below and viva voce of 50 marks.
