**ORDERS BY THE GOVERNOR
NOTIFICATION**

Dated Shillong, the 26th May, 2023.

NO.SUP. 48/2015/232 – In exercise of the powers conferred under sub section (1) of section 40 of the National Food Security Act, 2013 (Central Act No.20 of 2013), the Governor of Meghalaya is pleased to amend the Meghalaya State Food Commission Rules, 2014, as follows:-

1. **Short title and commencement :-** (1) These Rules may be called the Meghalaya State Food Commission (Amendment) Rules, 2023.
(2) They shall come into force on the date of their publication in the Official Gazette.

2. **Amendment to Rule 6.** – Rule 6 shall be read as :-

“Tenure of the Chairperson and Members- The Chairperson and every other Members shall hold office for a term not exceeding five years from the date on which he enters upon his office and shall be eligible for reappointment :

Provided that no person shall hold office as the Chairperson or other Member after he attained the age of sixty-five years.”
