Dated Shillong, the 7th February, 2025.

NO.SUP. 53/2022/136 - In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Meghalaya, is pleased further to amend the following Rules the Meghalaya Food and Civil Supplies Service Rules, 2001, namely:-

1. Short title and commencement (1) These rules may called the Meghalaya Food and Civil Supplies Service (Amendment) Rules, 2024.

(2) It shall come into force at once.
2. Amendment of Rule 5 :- In rule 5 of the Meghalaya Food and Civil Supplies Service Rules, 2001 (hereafter referred to as the Principal rules) for the words “those holding the posts in Grade-II and Grade-III, shall be Group “B” and Group “C” non-Gazetted respectively”, the words “those holding posts in Grade-II shall be Group- “B” Gazetted, and those holding posts in Grade-III shall be Group- “C” Non Gazetted” shall be substituted.
3. Amendment of Schedule-I:- In Schedule-I of the Meghalaya Food and Civil Supplies Service Rules, 2001, the existing Schedule-I shall be substituted as follows:-
