- a. Earnest Money Deposit of amount as mentioned shall be in the form of crossed Demand Draft /Cheque in favour of the Director of Food Civil Supplies & Consumer Affairs, Meghalaya, Shillong issued from any Nationalized Bank.
- b. Earnest Money Deposit shall be valid for a minimum period of 90 (Ninety) days from the last day of submission of Quotation.
- c. The Earnest Money Deposit of unsuccessful bidders will be returned within 30 days on their request, after issuance of LOA to the successful firm.
- d. The Earnest Money Deposit of the successful bidder will be discharged after the bidder has furnished the required acceptable performance guarantee and has signed the contract Agreement whichever is later.
- e. No interest shall be paid by the department on the Earnest Money Deposit.
- The Non-refundable cost of Quotation document shall be in the form of crossed Demand Draft /Cheque in favour of the Director of Food Civil Supplies & Consumer Affairs, Meghalaya, Shillong issued from any Nationalized Bank.

#### **Public Relations Preferences:**

- 1. The Public Relations Firms (PRF) should have a minimum two-year experience working with government organisations in similar projects and campaigns.
- 2. PRF should have its team members working for National Government organizations for at least 2 years
- 3. PRF should have capacities, expertise and experiences in producing short videos for government organisations.
- 4. PRF should have experiences working in public engagement exercises by the government in reaching out to all 11 districts and 46 Blocks
- 5. PRF need to have prior experiences in working with government organisations in producing pamphlets, posters, banners, standees and other public relations/ IEC materials
- 6. PRF need to show results on how a government engagement with them has resulted in tangible and measurable results
- 7. PRF should have had experiences in writing press briefings/ releases/ updates etc
- 8. PRF should have had experiences in conducting Press Conferences in the past
- 9. Preferences will be given to PFR which can show evidence of their works with the government in recent past
- 10. PRF should have had ample rapport with journalists/ media houses/ press club/ media leaders etc
